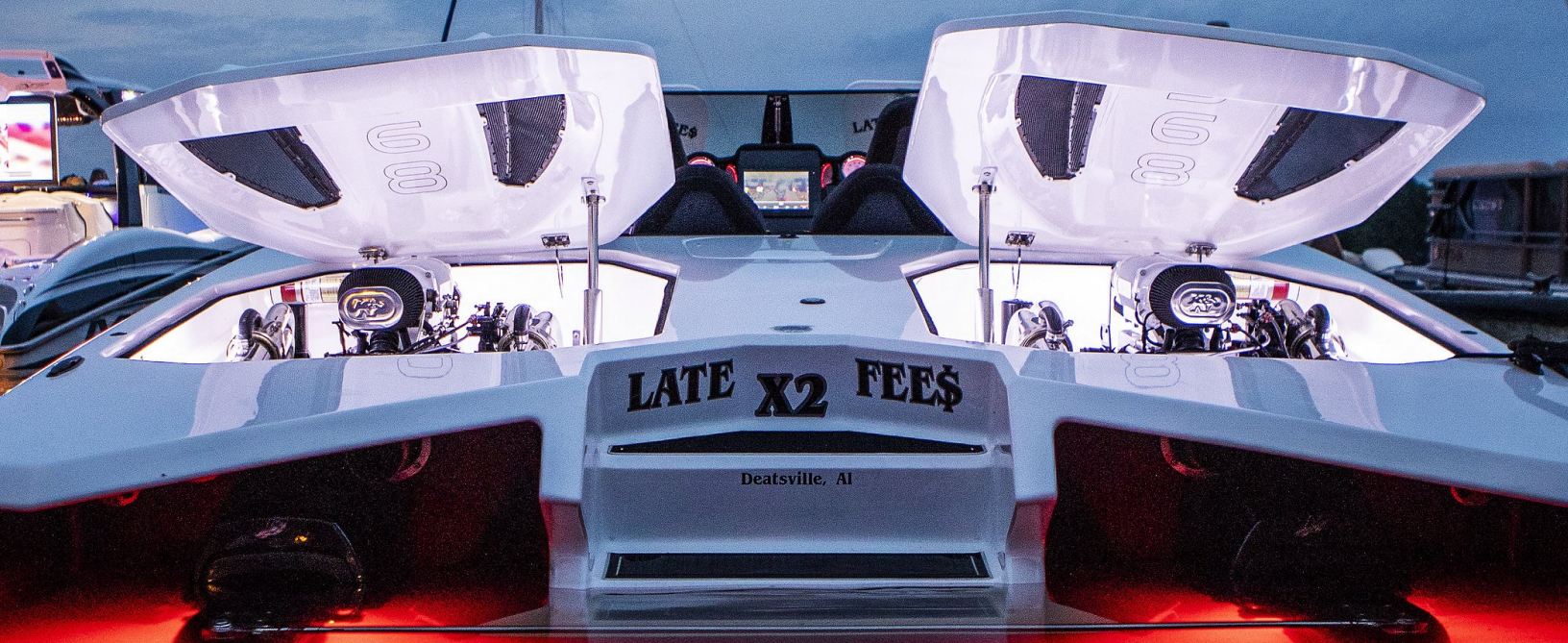

Lake Murray, fed by the Saluda River, is one of South Carolinas largest lakes. It boasts of 650 miles of shoreline, 41 miles long, and 14 miles wide at its widest point. Lake Murray has plenty of clean water for everyone!

When completed in 1930, Lake Murray was the worlds largest man made reservoir with the worlds largest earthen dam.

Just below the surface you can find dozens of flooded communities, the Wyse Ferry Bridge, bomber airplanes, and practice bomb fragments.

WAIVER OF RELEASE**

ALL CAPTAINS MUST AGREE IN ORDER TO PARTICIPATE

In consideration of participating in the Children's Chance of South Carolina Charity Run on June 21 and 22, 2019, (the "Charity Run"), I do hereby waive, release, forever discharge, and hold harmless Children's Chance of South Carolina and its director, employees, volunteers, board members, independent contractors, agents, successors, and assigns (collectively, the "Released Parties") from and against any and all liability in connection with my participation in the Poker Run, including but not limited to claims, demands, actions or causes of action, costs or expenses arising out of damages to personal property, personal injury, or death, which may result from my participation in the Poker Run. In executing this Waiver of Liability and Release, it is my intent to fully waive, release, and discharge the Released Parties, and to hold them harmless, from any and all liability in connection with my participation in the Poker Run to the fullest extent permitted by law.

I hereby acknowledge that my participation in the Charity Run is voluntary and solely at my own risk. I hereby agree to follow all rules established by Children's Chance of South Carolina in connection with my participation in the Charity Run. I agree to wear a life jacket at all times while participating in Charity Run activities. I assume full and sole responsibility for any damage or injury to myself, my personal property or any other individual and / or caused by me resulting from my participation in the Project. Notwithstanding the foregoing, I reserve the right to assert any claims against any third parties (i.e., persons outside the scope of the Released Parties) who may cause me injury or otherwise incur liability to me while I am participating in the Project.

I also understand, and it is my full intent, that this Waiver of Liability and Release binds (in addition to myself) my heirs, personal representatives, administrators, assigns, and any and all other individuals or entities who may have a claim or who may assert a claim by virtue of any injury or damage that I may incur during my participation in the Charity Run.

I agree that in the event that any portion of this Waiver of Liability and Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Waiver of Liability and Release, which shall continue to be enforceable.

To the extent that any reviewing court may conclude that this Waiver of Liability and Release is too broad to be legally enforceable, I hereby declare my intention that the court enforce it to the fullest extent the law would allow, or to otherwise modify this Waiver of Liability and Release to fully account for my unequivocal intent to release the Released Parties from liability as consideration for allowing me to voluntarily participate in the Charity Run.

By affixing my signature below, I acknowledge that I have read and understand this entire Waiver of Liability and Release and agree to be bound by it. I also acknowledge that my boat is currently covered by a valid liability insurance policy.
